

THE PRE-AUTHORIZED GIVING PROGRAM (PAG)

Do you subscribe to the Pre-Authorized Giving Program? Would you be interested? Here is a brief outline of this program:

The Pre-Authorized Giving Program (P.A.G.), administered by the Archdiocese of Toronto **BUT** tax receipted by your Parish Office, is established to assist you in your support of the parish through regular offertory offerings. The work of the parish is made possible through the giving hearts of parishioners. In response to changing parishioner lifestyles and demands on time and energy, the Parish seeks, through the Pre-Authorized Giving Plan, to assist you in your giving.

Participation advantages are MUTUAL

To the Parishioner: Convenience. Your offering is received automatically each month AND assures Continual support of your Parish, even in your absence.

To the Parish: Permits the Parish to better plan when offerings are regular and dependable AND The reduction in paperwork and bookkeeping.

OFFERTORY/SHARE LIFE GUIDELINES

If your usual contribution is \$20.00/week, to maintain the same level of giving, your PAG donation will be \$87.00 per month; at \$30.00/week, it would be \$130.00 per month; and at \$10.00/week, it's \$43.00 per month. You can also choose to give a set **fixed amount** monthly (example \$ 100 per month)

The same formula/process can be applied if you want to donate to the Share Life Fund.

CANCELLATION OF P.A.G. AGREEMENT

Withdraw from the PAG program at any time by a letter/email to the parish with 30 days' notice. If a withdrawal is not consistent with this PAG agreement, you have the right to receive reimbursement. For more information on your recourse rights, please contact your financial institution or visit www.cdnpoy.co. **NOTE** – An "NSF" charge of \$ 6 will be applied for each NSF advised by your bank.

WHY PRE-AUTHORIZED GIVING?

Pre-Authorized Giving Plan was introduced at the request of several parishioners who used it elsewhere, in the past, and found it meets their needs and lifestyle. This plan is not for everyone, but we are making it available to those who would want to use it. We respect that giving is a very personal decision but hope that the convenience and efficiency it brings might also encourage some parishioners to consider availing of this option.

Those who opt for this program can still use their offertory envelopes and indicate "PAG" on the weekly envelopes. Drop off your PAG requests in the weekend collection boxes OR in the parish office mail slot OR in person at the parish office. We look forward to your participation.
